Northcott's Rules and Regulations

Participating shops must:

- 1. Exist as a brick and mortar quilt shop, have purchased Northcott's Pony Express collection, and paid the program registration fee of \$150.* The registration fee will be credited to your Northcott account in December 2017.
- 2. Create an original block pattern to be used as the shop's exclusive design and to distribute in-store free of charge. Shops may outsource the design of their block pattern at their own expense. Appropriate copyright laws and actions must be considered. Any copyright infringements will result in expulsion from the program.
- 3. Distribute the free block pattern only to in-store consumers and provide them with the shop's customized sticker and a postcard if needed. One pattern and sticker per consumer.
- 4. Ensure the block patterns are created with accuracy. Northcott will not be held liable for any errors in block patterns.
- 5. All block patterns and kits are to be made available as of September 9th, 2017.
- 6. Between the periods of September 9th September 24th, 2017, all block patterns and kits may not be distributed online, by mail, or at venues outside the registered shop, such as shows or events. Shops may distribute their block pattern and kits through any venue after September 24th, 2017.
- 7. All kits for sale must include the shop's free block pattern.
- 8. Follow the rules and guidelines set out by Northcott Challenges.
- 9. Promote/advertise the Pony Express Block Party in their newsletter and social media outlets for the duration of the block party.
- 10. Participate in Northcott's social media campaign by adhering to submission dates and deadlines. Any shop that submits late social media requirements will not be included in sections and/or the entirety of Northcott's social media campaign.

*Customers registering more than one shop location for the Pony Express Block Party must sign a registration form and pay the \$150 registration fee for each participating location.
